Official Rules

2/20/2025

1. A player may use some or all of his or her points for entry into Points for Drawings™ promotion. The North Dakota Lottery (NDL) website and NDL Players Club website will include a description of the item or product to be awarded in the Points for Drawings™ promotion, anticipated entry and draw dates, and point cost for each Points for Drawings™ entry. Draw dates are subject to change as determined necessary by the NDL. The NDL will attempt to post all changes to scheduled Points for Drawings™ drawing dates on the NDL website.
2. In order to be eligible to win, players **must have a North Dakota mailing address** registered with the NDL Players Club. If a winner is deemed to not have a valid North Dakota mailing address registered, the winner will be disqualified and an alternate winner will be selected. Points *will not* be refunded to disqualified winners.
3. Points redeemed for a Points for Drawings™ promotion earn entry into the drawing. The odds of a player being selected to win the prize in each drawing depend upon the number of entries purchased through the redemption of points by all players.
4. The point cost of an entry into a Points for Drawings™ promotion will be displayed on the website for each drawing.
5. To use Points for Prizes® points to redeem entries into a Points for Drawings™ promotion, a player must select the drawing on the North Dakota Lottery Players Club® website that he or she wishes to enter, designate the quantity of entries, and submit the order.
6. It is the player's responsibility to ensure that the appropriate drawing and quantity are selected.
7. Once the entry order has been submitted, points will be deducted from the player's Points for Prizes® account and cannot be canceled or returned for the point value of the entries.
8. Points for Drawings™ promotion entries are eligible only for the drawing for which they were redeemed. Unless specified otherwise on the drawing description, Points for Drawings™ entries are eligible for one (1) drawing only.
9. Unless otherwise specified on the North Dakota Lottery Players Club website, a player may win no more than one (1) prize in a Points for Drawings™ drawing.
10. NDL shall attempt to contact each Points for Drawings™ promotion winner by telephone and/or email, by using the winner's registered telephone and/or email address.
11. The winner's name and hometown will be published on both the NDL website and the NDL Players Club website.
12. A Points for Drawings™ promotion winner assumes the risk of loss and is subject to disqualification if:
 - (a) NDL or MDI is unable to contact the winner within 7 days of the end of the drawing;
 - (b) Contact or attempted contact is not acknowledged in a timely manner as determined in the sole discretion of the NDL;

- (c) Any other deadline or requirement in these rules or other applicable rules or procedures is not met by the player; or
 - (d) A deadline or requirement that may become necessary is not met by the player, whether or not that requirement or deadline is contained in these rules.
13. There are ten (10) \$1,000 Cash Prizes/NASCAR Powerball Playoff™ Entries that will be awarded. Ten (10) individual winners will be selected. Winners are subject to set off of certain debts. See Section 17 for details.
 14. The drawing for the ten (10) \$1,000 Cash Prizes/NASCAR Powerball Playoff™ Entries will be held July 9, 2025.
 15. **Prizes valued at \$600, or more, are subject to federal and state taxes. Prize winners are responsible for any applicable taxes and will receive a North Dakota Lottery Players Club Prize Claim form from the North Dakota Lottery. Winners are to fill out the appropriate form and send back to the North Dakota Lottery. Once the prize form is received by North Dakota Lottery, prize delivery can take from seven (7) to ten (10) business days.**
 - (a) **One (1) One Thousand Dollar (\$1,000.00 USD) Cash Prize;**
 - (b) **One (1) Entry into the NASCAR Powerball Playoff™ Promotion.**
 - (c) **Total Prize Value: One Thousand Dollars (\$1,000.00 USD)**
 16. Per NDCC 10-16-10-04. Additional conditions. Subsection 11: The North Dakota Lottery reserves the right, in its sole discretion, to modify, suspend, postpone, or cancel, with or without notice, any portion of this promotion at any time and for any reason, including the award of any prize with the approval of the North Dakota Lottery's director or the director's designee.
 17. Winners are subject to set off of certain debts. If a drawing winner fails to satisfy an outstanding debt within the time frame specified by the NDL, then the NDL may, at its sole discretion disqualify the winner and the next alternate may become the winner. This rule pertains to cash prizes only and excludes any merchandise prize won.
 18. A decision to replace a winner with an alternate is within the sole discretion and judgment of the NDL. Once the decision to proceed with an alternate is made, the person who previously was selected as the prize winner is no longer entitled to a prize.
 19. Points for Drawings™ prizes are non-transferable.
 20. The NDL will not exchange a Points for Drawings™ prize for cash.

NASCAR POWERBALL PLAYOFF™ PROMOTION (2025) OVERVIEW AND GUIDELINES

1. **Entry into the NASCAR Powerball Playoff™ Promotion and HOW IT WORKS:**
 - (a) Entrants from all participating lottery jurisdictions will be entered into an initial drawing, in which sixteen (16) semi-finalists will be drawn, with no more than one semi-finalist per lottery advancing.
 - (b) Sixteen (16) semi-finalists will go head-to-head in a series of drawings that mirror the elimination rounds of the NASCAR Cup Series Playoffs™ to determine four (4) finalists who will win a VIP trip for two to the NASCAR Cup Series Championship Weekend™ at Phoenix Raceway®. One (1) of the four (4) finalists will win \$1 million in a drawing broadcast live from the NASCAR Cup Series Championship™ Race.
 - (c) The Multi-State Lottery Association (MUSL) will perform a total of five (5) drawings. The first four (4) drawings will be performed by on a Digital Draw System (DDS), and the final drawing will be performed using a mechanical draw machine on November 2, 2025, at the NASCAR Cup Series Championship Race live at Phoenix Raceway.
 - (d) Drawings will follow the schedule as outlined below:
 - i. **Drawing 1 – Round of 16 – August 7, 2025 – MUSL DDS**
 1. MUSL will draw sixteen (16) semi-finalists from the national pool of entrants.
 2. No more than one player per lottery jurisdiction will advance as a national semi-finalist.

3. Public announcement of sixteen (16) semi-finalists on **Aug. 23, 2025**, during the race at Daytona International Speedway in Daytona Beach, FL.
- ii. **Drawing 2 – Round of 12 – August 27, 2025 – MUSL DDS**
 1. MUSL will draw from sixteen (16) to twelve (12) semi-finalists.
 2. Four eliminated players win \$2,500.
 3. Public announcement of twelve (12) semi-finalists on **Sept. 13, 2025**, during the race at Bristol Motor Speedway in Bristol, TN.
- iii. **Drawing 3 – Round of 8 – September 17, 2025 – MUSL DDS**
 1. MUSL will draw from twelve (12) to eight (8) semi-finalists.
 2. Four eliminated players win \$5,000.
 3. Public announcement of eight (8) semi-finalists on **Oct. 5, 2025**, during race at Charlotte Motor Speedway in Charlotte, NC.
- iv. **Drawing 4 – Round of 4 - October 8, 2025 – MUSL DDS**
 1. MUSL will draw from eight (8) semi-finalists to four (4) finalists.
 2. Four eliminated players win \$7,500.
 3. Public announcement of four (4) finalists on **Oct. 26, 2025**, during the race at Martinsville Speedway in Martinsville, VA.
- v. **Drawing 5 – November 2, 2025 – Mechanical Ball Machine**
 1. Drawing will take place from four (4) finalists to one (1) winner.
 2. One (1) \$1 million grand prize winner and three (3) \$10,000 winners
 3. Final drawing will be broadcast live from the NASCAR Cup Series Championship Race on Nov. 2, 2025, at Phoenix Raceway in Avondale, AZ.

THE TERM “PARTICIPATING LOTTERY” OR “PARTICIPATING LOTTERIES” MEANS THOSE LOTTERIES THAT HAVE OFFERED THE NASCAR-POWERBALL PLAYOFF PROMOTION.

THE TERM “PRIZE PROVIDER” IS THE MULTI-STATE LOTTERY ASSOCIATION (MUSL), OR, A THIRD-PARTY UNDER CONTRACT WITH MUSL TO FULFILL ALL ELEMENTS OF THE TRIP PRIZE EXCEPT THE SECOND PLACE CASH PRIZE OF \$10,000, AND THE \$1 MILLION PRIZE.

Finalist and their guest (“Guest”) must travel on the same dates and times selected (on or about Friday October 31, 2025, and Monday, November 3, 2025), to participate in the Trip Prize. If Finalist and Guest are unable to or will not travel on the dates and times selected by the prize provider, the selected Finalist may choose a proxy on or before October 15, 2025. If no proxy is chosen by Finalist, Finalist will forfeit the Trip Prize (including attendance by Guest) but will still be entered into the drawing for and eligible to win the \$1 Million Prize and will be represented by a proxy provided by the appropriate Participating Lottery.

If Finalist resides fewer than two hundred fifty (250) miles from Phoenix, AZ, Prize Provider, in its sole discretion, reserves the right to provide ground transportation for Finalist and Guest in lieu of airline transportation. If Finalist is under the age of twenty-one (21), Guest must be at least the age of majority in Guest’s state of residence. If Finalist is twenty-one (21) or older, Guest may be under the age of eighteen (18) but must be at least thirteen (13) years old (as of the first date of travel), and if Guest is a minor in Finalist’s state, Finalist must be the parent or legal guardian of Guest.

Finalist will

Finalist must execute and return all required documentation to Participating Lottery within five (5) days of Finalist's receipt (or such shorter period as production exigencies may require). If Finalist elects to appoint a proxy, they must appoint the proxy and provide contact information for the proxy on or before **Wednesday, October 15, 2025**.

- If Finalist chooses a proxy, the proxy must satisfy the Production Requirements to participate in the Trip Prize and/or participate in the broadcast of the Program. In the event that Finalist's designated proxy does not satisfy the Production Requirements, Prize Provider reserves the right, in its sole discretion, either to (i) allow Finalist to appoint another proxy to participate in the Trip Prize and/or to appear in the Program in Finalist's place (subject to Prize Provider's production schedule and deadlines and satisfying the Production Requirements); or (ii) a proxy will be selected by Prize Provider to appear in the Program in Finalist's (or proxy's) place.

The appropriate Participating Lotteries will determine, and collect taxes due on the Trip Prize, and other tiers of cash prizing, as well as the \$1 Million Prize.
